- I/We the undersigned hereby apply for membership for 2020 and agree to abide by:
- A. The By-Laws of the Club and to waive and indemnify the Club from liability for the loss and damage of personal property left on the premises and in the power cart storage buildings adjacent to the premises.
  - B. Charging Account Privilege rules:
    - 1) Available to adult members in good standing whose membership fees are paid in full for the current season. (Unless on approved payment plan).
    - 2) I will receive a \$300 limit on my charge account, on which I can charge purchases made in the Pro Shop and Clubhouse, and will not exceed the amount unless previously authorized by the Club Professional.
    - 3) An account statement will be sent to me after each month. It is my responsibility to check on the account balance, whether I receive an invoice or not.
    - 4) My account is due at the end of the month and I will pay in full any outstanding amount by the due date.
    - 5) A late fee of 2% will be charged on any overdue balance.
    - 6) Accounts 60 days overdue will be immediately payable and I will lose any further charging privileges for the remainder of the golf season.
    - 7) Accounts must be paid in full by October 31, 2020, or I will lose my charging privileges for the next golf season.
    - 8) I will not be able to apply for membership for the following season if my account is not settled before applying for membership for that year.
    - 9) There will be no charging privileges after September 30 of the current season.
    - 10) **The Food & Beverage Assessment credit of \$199 can be used towards FOOD & BEVERAGE PURCHASES ONLY. It CANNOT be used for Pro Shop purchases or other account charges.**
    - 11) **Any Food & Beverage Assessment Credit remaining unused at the end of the season (October 15, 2020), will be forfeited. Food & Beverage Assessment Credits CANNOT be carried over to the next season.**
